I hereby release, covenant not to sue, discharge, and hold harmless Jacquelyn Reiff Pilates & Movement, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Jacquelyn Reiff Pilates & Movement, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Jacquelyn Reiff Pilates & Movement program.

I voluntarily agree to forgo participation and attendance at Jacquelyn Reiff Pilates & Movement if I have any of the following confirmed COVID-19 symptoms:

*Cough*  
*Shortness of breath or difficulty breathing*  
*Fever*  
*Chills*  
*Muscle pain*  
*Sore throat*  
*New loss of taste or smell*

*This list is not all possible symptoms. Other less common symptoms have been reported, including gastrointestinal symptoms like nausea, vomiting, or diarrhea.*

I voluntarily agree to notify and inform Jacquelyn Reiff Pilates & Movement if I have tested positive for COVID-19 after attending and participating in class at Jacquelyn Reiff Pilates & Movement. I acknowledge that my identity will remain confidential after notifying Jacquelyn Reiff Pilates & Movement of a positive COVID-19 test.
